Cookie Policy

Introduction

This Cookie Policy explains how GCEX (a trading name of GC Exchange Limited, GC Exchange A/S and GC Exchange FZE) use cookies and similar technologies to recognise you when you visit our websites (www.gc.exchange, www.prime.gc.exchange, knowledge.GC.Exchange/knowledge)

Cookies are small text files that are placed on your computer by websites that you visit. They are used to improve user experience, make websites work, as well as to provide information to the owners of the site.

GCEX uses cookies to provide the functionality you need to browse our site. Please note that with cookies switched off, many areas of our website and services will not be made available to you. Please note that not all the cookies on our site are set by us and some are third party cookies. These cookies, include:

- Essential website cookies: These cookies are strictly necessary to provide you with services available through our Websites.
- Performance and functionality cookies: These cookies are used to enhance
 the performance and functionality of our Websites but are non-essential to
 their use. However, without these cookies, certain functionality may become
 unavailable.
- Analytics and customisation cookies: These cookies collect information that is
 used either in aggregate form to help us understand how our Websites are
 being used or how effective our marketing campaigns are, or to help us
 customise our Websites for you.
- Advertising cookies: These cookies are used to make advertising messages
 more relevant to you. They perform functions like preventing the same ad

from continuously reappearing, ensuring that ads are properly displayed for advertisers, and in some cases selecting advertisements that are based on your interests.

Some of the cookies we use are essential for the site to work

We also use some non-essential cookies to collect information for making reports and to help us improve the site. The cookies collect information in an anonymous form. The table below explains the cookies we use and why:
